Sub. : Membership Subscription for the Year 2023-24

This is to advise Member Publications that in terms of **Article 79** of the Articles of Association of the Society, Membership Subscription for the period covering **01 April, 2023 to 31 March, 2024 falls due for payment by March 31, 2023**. The relevant provision is reproduced below:-

“79 (i) Every member shall pay to the Society by 31st March of each year an annual subscription in respect of succeeding year at the following rate as applicable to him or at such other time for such period, retrospectively or otherwise, and at such rate as the Executive Committee may, from time to time determine”.

The Executive Committee has fixed the rates as under:

The payment towards subscription as mentioned above must be accompanied by a Circulation Certificate from ABC / CA / RNI, as per **Article 79 (ii)** stated below:-

“79 (ii) For the purpose of determining the rate of annual subscription payable by a member under clause (i) (a), (b), (c), (d) and (e), the Society shall accept the latest certificate issued by the Audit Bureau of Circulations and where such a certificate is not available, the certificate issued by the Chartered Accountants or when both these are not available, the latest circulation figures available with the RNI as published by that office as authenticated circulation figures.”

The Membership Subscription should only be remitted along with CA/RNI/ABC circulation certificate for Yr. 2021-22 or January - December, 2022 (12 Months). If the payment is not accompanied with a circulation certificate as mentioned above, the payment would be returned.


Lastly, your attention is drawn to **Article 8 clause 8 (a) and 8 (d)** of the Articles of Association stating the following:-

“8. A member shall cease to be a member of the Society in any of the following events:-

- a) Upon the closing down of the newspaper in respect of which the member in the Society exists. A newspaper shall be deemed to have been closed down if the publication of the newspaper has been discontinued or stopped, for any reason whatsoever, for a continuous period of 365 days.”*
- d) Upon a member failing in the first instance to pay the annual subscription for any year on due date that is by March 31st of the preceding year and continuing to do so up to June 30th, following in spite of three reminders having in the meantime, been sent to him, the last of which should under registered post, such cessation taking automatic effect from July 1st of the year for which the subscription has fallen due.”*

All Members are requested to pay the INS Membership Subscription for the Yr. 2023-24 along with the circulation certificate as mentioned above on or before 31st March 2023.
